. Program: Preparation of the december forum in Brussels

After an introduction on the political situation with the ongoing elections results in France and those to come on a European scale, we confirmed our will to hold our December meeting of Brussels and to enlarge as much as possible our network to new partners. Brussels represents a stage toward the european Forum Social in September 2008 in Sweden..

The greek delegation has once again proposed to organise a public services forum in spring 2008, that seems difficult before the september's FSE for wich we must prepare our presence.

The Convention of Local Communities "Out of GATS" also announced its convention in 2008, in a place that is not yet determined.

Brussels

- Place and Date: 5 and 6 december 2007, the venue will be facilitated by the GUE/NGL with translation means. Another place will be necessary to welcome the first half of the program.
- Organisation and distribution of the tasks:

Those groups are opened and welcome all of those ready to involve

- Workgroup on the logistics, Access to the European Parliament implies serious pre-registration, translation setup and translators will be necessary for the first day (AITEC, SOLIDAIRES)
- Workgroup on the plenaries organisation, constitution of the panels, developing the themes and prepare the documentation for translation teams ADEDY has already proposed to participate in the Public services in Europe session. (ATTAC, FSU)
- Workgroup on the Brussels call , text of mobilisation on the meeting of Brussels, a project will be issued by the end of july (CGIL)
- Workgroup dedicated to the elaboration of a document like the « Eurobarometer » of the commission, with up to date data on public services on prices, quality of service and prices issues in sectors since their market opening (transports, health, education, energy, postal sector, telecommunications, etc..) A framework of this document will be issued by july and all are invited to contribute (Solidaires, Résistances Sociales, STWU), first draft of the document for the 24th of September.
- A proposal for the website will issued by the CGIL in the next weeks (cost and frame), documentation on the network might be found at the following address:
